

AORI ACCEPTABLE USE POLICY

This Acceptable Use Policy (“**Policy**”) outlines the rules and standards that govern the use of the Aori Technologies Ireland LTD platform. By accessing or using the computer program 24GEN («**Aori platform**»), you agree to adhere to this Policy in full. Failure to comply may result in account suspension, termination, or other remedial actions.

1. General Use Restrictions

- You may use the Aori platform only for lawful purposes and in compliance with all applicable laws, regulations, and codes of conduct.
- Any use that disrupts, damages, or interferes with the integrity or performance of the Aori platform, other users’ experiences, or the Aori network is prohibited.

2. Prohibited Content

- **Illegal or Harmful Content:** You may not upload, share, or distribute content that is unlawful, harmful, abusive, defamatory, obscene, harassing, or otherwise objectionable.
- **Intellectual Property Infringement:** Content that infringes on third-party intellectual property rights (e.g., copyright, trademark, patent) is strictly prohibited. You must have the necessary rights to use and share all content on the platform.
- **Hate Speech and Discrimination:** Aori does not permit content that promotes or incites violence, discrimination, or hostility against individuals or groups based on race, religion, ethnicity, gender, sexual orientation, or other protected characteristics.
- **Malware and Malicious Code:** You are prohibited from uploading, distributing, or linking to any viruses, trojans, worms, malware, or other harmful software intended to disrupt or damage the Aori platform or any third-party system.

3. Prohibited Activities

- **Unauthorized Access:** You may not attempt to access or interfere with any accounts, systems, or data that do not belong to you. Unauthorized access, such as hacking, password mining, or circumventing security measures, is prohibited.
- **Data Scraping and Harvesting:** Collecting information or data from the Aori platform through automated means, such as web scraping, bots, or similar methods, is not allowed.
- **Phishing and Fraud:** Aori prohibits any attempts to impersonate Aori, other users, or third parties. Engaging in fraudulent activities, including phishing, identity theft, or deceptive marketing, is strictly forbidden.
- **Spamming and Unsolicited Communications:** Sending or distributing unsolicited communications, advertisements, promotions, or other commercial messages without permission is not allowed on the Aori platform.
- **Overuse and Excessive Load:** Activities that place an unreasonable or disproportionately large load on Aori’s infrastructure or network (e.g., DDoS attacks, resource-intensive scripts) are strictly prohibited.

4. Privacy and Personal Data

- **User Privacy:** You must respect the privacy and data protection rights of other users and third parties. This includes not accessing, collecting, or processing personal data without lawful consent.
- **Sensitive Data:** Do not upload, store, or share sensitive data, such as financial, health, or other confidential information, unless necessary and compliant with all relevant privacy laws and regulations.

5. Third-Party Services and Integrations

- **Authorized Use Only:** If you choose to integrate third-party services with the Aori platform, you are responsible for ensuring that your use of such services complies with the terms of the third-party provider.
- **Liability for Third-Party Interactions:** Aori is not liable for any actions or outcomes resulting from interactions with third-party services. You are solely responsible for any consequences arising from such integrations.

6. Intellectual Property and Content Ownership

- **Non-Infringing Content:** You may only upload and share content that you own or have the necessary rights and permissions to use. Using third-party content without authorization is strictly prohibited.
- **No Reverse Engineering:** You are prohibited from reverse-engineering, decompiling, or otherwise attempting to extract source code or algorithms from Aori's proprietary software or systems.
- **Derivative Works:** You may not create derivative works based on Aori's intellectual property without explicit permission from Aori.

7. Prohibited Uses of AI Tools

- **Misuse of AI-Generated Content:** AI-generated content provided by Aori's tools should not be used in any way that is harmful, misleading, or otherwise in violation of this Policy.
- **Illegal or Misleading Applications:** You may not use AI features to generate illegal, false, or deceptive content, or content intended to deceive others.

8. Security Standards

- **Account Security:** You are responsible for maintaining the security of your account credentials, including usernames and passwords. Sharing your account or allowing unauthorized access is prohibited.
- **Security Testing:** You may not conduct security testing (such as penetration testing, vulnerability scanning, or stress testing) on the Aori platform without prior written authorization from Aori.
- **Reporting Security Vulnerabilities:** If you discover a security vulnerability within the Aori platform, you are encouraged to report it immediately to Aori at support@Aori.ai and agree not to exploit it.

9. Compliance with Local and International Laws

- **Legal Compliance:** You are required to comply with all applicable local, national, and international laws when using the Aori platform.
- **Export Control and Sanctions Compliance:** You may not use Aori to engage in activities that violate export controls, trade sanctions, or other governmental restrictions. Users located in sanctioned regions are not permitted to access or use the platform.

10. Enforcement and Penalties

- **Remedial Actions:** Aori reserves the right to investigate any suspected violations of this Policy. If violations are confirmed, Aori may take action, including but not limited to

suspending or terminating your account, removing prohibited content, or notifying law enforcement.

- **Notification of Violations:** Where feasible, Aori will make reasonable efforts to notify you of any violations and allow you an opportunity to address the issues. However, Aori retains full discretion to act immediately in cases of serious breaches or legal risks.
- **Indemnification:** You agree to indemnify and hold Aori harmless from any claims, damages, or expenses arising from your violation of this Policy, including legal fees incurred by Aori.
